# Nonviolent Crisis Intervention® Flex Training (CPI)



**The Flex ON-LINE learning experience - A blended learning course**

What is CPI? The ability to prevent and/or positively manage disruptive, challenging, or aggressive behavior, without this training staff who encounter risk behavior are more likely to react from a fear instinct rather than respond in a manner that minimizes risk. During the classroom session participants will learn and safely practice any applicable physical disengagement and/or holding skills. At the classroom session, participants, will receive the ***Flex Participant Job Aid***, for on the job reference information. Participants will be forwarded a CPI card upon passing post-test and completing participant evaluation at day of training.

Participants interested in signing up for a CPI Flex training date are asked to register for the Instructor training date (listed below). Participants will receive a registration pending notification, as well as future email reminders through the OMS program. **Please note:** participants registered for CPI Flex are required to **complete an on-line module of the CPI Flex course, prior to the training date**, you will need a computer or tablet, internet access, and speakers for this portion (closed caption is available). **Note: cell phones are not an option.** The online training and quiz should be completed as soon as possible but no less than within two-day prior to the training. Participants cannot attend without taking and passing the entire online course, online training will be monitored by our office. Course will take approximately one to three hours (you may exit the course and resume at any time). *You will receive a separate email with instructions on when the CPI training link is available, as the in-person training date approaches.*

While taking the online course, participants may download and print a copy of the ***Learner’s Guide*** to bring to the one-day CPI Certified Instructor session for review of key terms and definitions.
